Decolonization and Wabanaki Solidarity: We enact and support direct land return to Wabanaki organizations. In partnership with Wabanaki-led organizations we're building a model for Indigenous-settler relationship that places land control in the hands of Indigenous communities, while settler-led organizations cover all costs and administration, and enact accountable local land management. Our 99-year ground leases generate reparations payments to support Wabanaki land return.

Land Access for Collective Liberation: We transfer land out of private markets and into community ownership and we redistribute the use and care of this land to communities directly harmed by land injustice. We collaborate with BIPOC-led projects to find, acquire and protect life-long tenure of affordable, rural land for food production, housing, and recreation. We provide ongoing technical support for BIPOC-led land projects.

We work to steward and grow a land base that supports sustainable livelihoods, education, rural affordable housing, solidarity economies, and ecological integrity. We strive to create secure access to land for people and communities who experience exclusion from land ownership due to economic and racial injustice.

Land in Common removes land from speculative markets and places it into a member-run trust, to be cared for over the long-term by its residents. We are creating a multi-generational land base for sustainable livelihoods that supports communities working for just, cooperative, and resilient futures.

Caring for Commons: Land in Common holds in trust and stewards nearly 400 acres of rural land in Maine, for the purposes of creating rural affordable housing, promoting land-based solidarity economies, and fostering ecological integrity. The land supports two cooperative farms, Wild Mountain Cooperative, which grows subsistence produce, and Celebration Tree Farm and Wellness Center, which produces christmas trees grown in a community supported forest. The land also supports a community food security project, Presente! Farm, where all produce grown is distributed for free to residents of Portland and Lewiston who lack access to healthy and affordable food. Twelve acres are set aside for rural affordable housing, providing low cost homes for 12 residents of Wild Mountain Cooperative Farm. Sixty-three acres are farmfields and woodlot. Finally, acres of forest land and wetland are preserved as wildlands, for animal, fungi, and plant habitat.
